- 5. The make-up day policy is as follows: **THE STUDENT WILL BE REQUIRED TO MAKE UP ALL MISSED TIME.** However, for the Segment II six hour course, missing more than one day will result in the automatic failure of this course. The make

up day will be scheduled upon the students return to class.
